## Computer Damage/Loss Protection Plan Application Form

**Please read this entire document to determine if this program is needed for you and your student's protection against damage and loss of the loaned computer equipment in your care. Participation in this program is VOLUNTARY. This form must be completed and marked Yes or No before the computer will be provided to the student.**

**COVERAGE AND BENEFIT:** This program covers the computer equipment and carrying case loaned to the student against all damage or loss over \$50.00 per incident. Damage or loss of equipment or accessories valued less than \$50.00 are not covered. Total value will be determined by the District at the time of loss or damage. In no case shall the value be greater than the total cost to replace the item(s). In the event of damage or loss, the program will pay 60% of the amount of damage or loss and the student will be responsible for 40% of the amount of damage or loss per incident.

**EFFECTIVE AND EXPIRATION DATES:** This coverage is effective from the date this request form and premium payment are received by the school through the date at which the computer is requested to be returned in good order to the school.

**PREMIUM** The total nonrefundable cost is \$40.00 per school year.

### Program Description:

The Lewis Central School District offers your student the opportunity to participate in this Computer Damage/Loss Cooperative Program. This program is designed to protect students and families in the event the loaned computer equipment is lost, stolen, or damaged. Coverage is totally voluntary. A separate application will be needed for each computer covered. Loss or theft of the computer must be reported to the District by the next school day after the occurrence and a police report may be required. This agreement will only cover the total cost of one device. The loss or damage of the second device will require an additional purchase of the program.

**This form must be completed and returned to your child's school before computer equipment will be loaned to your student. One form per student is required.**

# Frequently Asked Questions

## Computer Damage/Loss Cooperative Program Application Form

**Question:** Do I have to buy the coverage in order to receive the device?

**Answer:** The plan is optional and not necessary to receive the device. Keep in mind that you are responsible for the device and it is expected to be returned in good working order. Similar to the expectations associated with the usage of other school equipment such as a textbook, music instrument, etc. the student is financially responsible for any damage to the device.

**Question:** How would the plan work if I accidentally dropped the device and the damage is such that it needed to be replaced?

**Answer:** Replacement cost of the device is currently \$197. You would be responsible for 40% of \$197 or \$78.80. Your total out of pocket would be the \$40 for the purchase of the plan plus the \$78.80 for a total of \$118.80 out of pocket.

**Question:** What if I lost the power cord?

**Answer:** The replacement cost for a power cord is under the \$50 minimum and would therefore not be covered by this plan. You would be responsible for purchasing a new cord at the full replacement cost.

**Question:** What if my computer is stolen?

**Answer:** The total replacement cost for the computer and shield is currently \$255. You would be responsible for 40% of the \$255 or \$102.00. Your total out of pocket would be the \$40 for the purchase of the plan plus the \$102.00 for a total of \$142.00 out of pocket.

**Question:** When I opened my bag I noticed my screen was cracked. Is that covered?

**Answer:** Yes. The same 40% of the cost would apply. For example, if a screen replacement is \$113 you would pay \$45.20. Your total out of pocket would be the \$40 for the purchase of the plan plus the \$45.20 for a total of \$85.20 out of pocket.

**Question:** We have two children at the high school. Do we need to purchase separate plans for each device?

**Answer:** Yes. Each plan only covers one device.
